<p><b>THE ANCIENT AND HISTORICAL MONUMENTS AND ARCHAEOLOGICAL SITES AND REMAINS (DECLARATION OF NATIONAL IMPORTANCE) ACT, 1951.</b> No. LXXI of 1951</p> <p><b>An Act to declare certain ancient and historical monuments and archaeological sites and remains in Part a States and Part B States to be of national importance and to provide for certain matters connected therewith.</b></p> <p style="text-align: right;">(28<sup>th</sup> November, 1951)</p> <p><b>Be it enacted by Parliament as follows:-</b></p> <p><b>1. Short title.</b> - This Act may be called the Ancient and Historical Monuments and Archaeological Sites and Remains (Declaration of National Importance) Act, 1951.</p> <p><b>2. Declaration of certain monuments and archaeological sites and remains to be of national importance.</b> - The ancient and historical monuments referred to or specified in Part I of the Schedule and the archaeological sites and remains referred to or specified in Part II thereof are hereby declared, respectively, to be ancient and historical monuments and archaeological sites and remains of national importance.</p> <p><b>3.
